June 21, 2017 Special Called Meeting

Mr. Wilson then summarized his directives:

- Get with Raymond James and King & Spalding on estimated bonding of just the resurfacing, \$8 million to resurface roads.
- \$13,750,000 to proceed with design and engineering on all 15 dirt roads as identified at the April 2017 meeting to a point to where the residents will know what affect paving their road will have on them. o Once planning and engineering is complete authorize Steve Manley to go to the residents, explain the impact that paving the road will have and proceed with acquisition of donated right of way for the individual roads.
- \$500,000 for Moreland Road/Tri-County Crossroads design and engineering.
- \$2 million for Orchard Hill Intersection.
- \$1.5 million to be set aside for Intersection #3 until we know if the GTIB will assist in funding this project. It will be added to contingency if the GTIB covers the costs.

Mr. Wilson will get pricing on installation of sidewalks from Intersection #2 to Intersection #3.

Set a Special Called Meeting and Public Hearing for July 17th at 10:00 a.m. and 11:00 a.m. respectively.

William,

The first attached file is the preliminary debt service schedule for the \$8 million GO issue you requested to fund the resurfacing projects in the T-SPLOST referendum. We have used interest rates that are roughly 50 basis points higher than the rates where the issue might sell in the current market and we have structured the issue for level annual debt service. It assumes the bonds are issued in the first half of 2018 with a first interest payment date of January 1, 2019, a first principal payment of July 1, 2019 and a final maturity of July 1, 2023. The estimated annual debt service is approximately \$1,710,000.

We have also taken the liberty of preparing similar schedules for issue sizes of \$10 million, \$15 million and \$20 million in case the BOC might want to authorize a larger amount to provide the flexibility to bond finance more of the projects, either initially or in a subsequent second series of bonds. **As you know, they would not have to issue all of the authorized bonds, but would have them available if needed.**

Let us know if you have any questions regarding the attached schedules or if you wish to see any other scenarios or structures. For instance, we could backload the principal amortization like we did with the SPLOST bonds last year. Once you decide on the amount and the structure, we can get the numbers to Floyd and Ansly to drop into the resolution.

William – when I spoke with Todd this afternoon, he mentioned a possibility that had not occurred to me which was whether you should include on the ballot (and validate) **bonds for more than the \$8MM you need for the resurfacing.** You could then issue the \$8MM when the transaction is approved, and the remainder of what you authorize could be issued later, if you choose to do so, when the engineering is complete, right of way is in place and the projects are, to use your terms, **“shovel ready.”** This is entirely up to you, but I just wanted to go ahead and mention it as it might **give the County some flexibility down** the road if it wanted to move ahead on some of the other projects without waiting on the sales tax proceeds to come in. If you did this, the process for issuing the additional bonds in the future would be pretty simple because the referendum would already have been held and the bonds validated. Floyd
